The Committee expressed concerns about the legality of the temporary mast installation, given

the unclear ownership and usage rights of the Community Centre land.

The Committee decided to await further development or communication from Thanet District

Council.

The Committee also discussed an enforcement notice regarding a garage conversion at 6 St

Mildreds Walk. The resident, Sarah Wiltshire, had appealed Thanet District Council's rejection

of the conversion to the Secretary of State. The Committee noted they have limited ability to

intervene in this enforcement case.
