### BUDGET/PRECEPT REQUIREMENT FOR 2016/17

Council considered the draft budget/precept requirement for the year 2016/17 and the Interim Town Clerk tabled amended proposals (Options 1 & 2) which reduced the impact of the proposed increases set out in the proposals tabled.

The Chairman set out his vision in respect of the future of Westgate-on-Sea and measures he would like to put in place to make the town and even more attractive place to live.

There followed a detail discussion on the main thrust of the budget details relating to the introduction and method of funding revised cleansing arrangements within Westgate-on-Sea and had regard to the recent survey and analysis of the survey "War on Rubbish.

(B) Thanet District Council be asked to confirm the last date on which the Town Council's precept requirement may be considered, (C) that a further meeting be held to consider the precept once the advice of TDC is received; and (D) Members of the Council to submit alternative budget proposals to the Interim Town Clerk for consideration at the appropriate meeting.
