2785	Allotment Gardens Site – Lymington Road Update and Review Following debate and a report prepared by the Finance Assistant including a review of the Allotment fees were considered, including the fees for water for the renewal of allotment plot licenses due on 30 <sup>th</sup> September 2021 It was RESOLVED: that the draft rules for the Allotment site were adopted, bonfire season is extended to include from 1 <sup>st</sup> September each year, a barrier be formed to ensure the communal toilet area is separate from the plot, a communal path is installed to serve the communal toilet, fees for water for the allotment plots on Lymington Road would increase to £28.00 per annum for a full plot and £14.00 per annum for a half plot with effect from 1 <sup>st</sup> October 2021.	
2786	Small Grants Fund Scheme Application and Donations  A) It was moved by Cllr Wallin and seconded by Cllr Nightingale and RESOLVED: that the application for a Small Grant Scheme funding for the amount of £500.00 from Westgate on Sea Lighting & Improvement Group for a purchase of a Christmas Tree was approved.
