### FC/26/01 Welcome from the Chairperson

The Chair opened the meeting and welcomed all present.

### FC/26/02 Apologies for Absence

Apologies for absence were received from Cllr Mulinya, Cllr Scott, Cllr Evans and PC England.

### FC/26/03 Members' Interests

### FC/26/04 Minutes

The minutes of the Full Council meeting held on 10<sup>th</sup> December 2025 were received and approved as an accurate record.

### FC/26/05 Public Right to Speak

### FC/26/06 Co-option Update on Councillor Vacancies

Cllr Donaldson explained that there are currently two vacancies: one will be filled by co-option at an Extraordinary Full Council meeting on the 4<sup>th</sup> of February, and the second will also be filled by co-option (as no election was requested), after the co-option advertising period ends on the 20<sup>th</sup> of February.

### FC/26/07 Proposed Amendment to Standing Orders

It was **RESOLVED** to adopt the amendment to Standing Orders in relation to changing meeting dates.

### FC/26/08 Policies

It was **RESOLVED** to adopt the Expenses and Allowance Policy, subject to removal of the line regarding non-reimbursement to members of travel expenses within Thanet.

It was **RESOLVED** to adopt the Working Party Policy.

### FC/26/09 Skatepark Update

Cllr Veck reported that Phase One of the skatepark is almost complete (second concrete pour due this weekend, opening hoped for about a week later), reported community fundraising and grants totalling several thousand pounds (including from the Westgate Christmas lights event, GoFundMe and a £5,000 TDC grant), and thanked Kelly's Café and volunteers for their support, noting that the Council is getting approximately £60,000 of work for about £13-14,000 due to the strong community effort.

**FC/26/10 Budget**

Cllr Veck, Chair of the Finance Committee, proposed that the 2026/27 budget should raise the precept from approximately £388,000 to approximately £422,000, an increase of about £34,000 or 8.8% (around £14.76 a year / 4p a day extra for a Band D property). Further discussions were postponed due to a breach of confidentiality.

**FC/26/11 Councillors' Reports**

Cllr Donaldson noted that Thanet District Council has approved the first consultation for a new Margate Town Council, with a shadow council expected in June/July, an estimated 19–20 councillors, a £1.2m precept, and no further update on local government reorganisation.

**FC/26/13 Report(s) from Steven England, Beat Officer for Westgate and Birchington, and/or Jason Gordon, Community Warden**

Jason Gordon, Community Warden, reported ongoing support for Westgate and Birchington, including running a community well-being group, supporting community safety and cybersecurity talks, providing drugs and alcohol awareness sessions, helping a local church serve meals, delivering emergency food supplies, and continuing to report potholes and highways issues.
