Following debate Members agreed to defer the decision until the next meeting in January 2023. It was moved by Cllr Wallin and seconded by Cllr Donaldson and RESOLVED: that the budget will be debated again at the January 2023 meeting when it is hoped that a provisional Council Tax Base figure for Westgate will be available and can be used to estimate a percentage movement in relation to the proposed Precept request for 2023/2024

Cllr King added that the proposed 5G mast was a prominent issue and it was disappointing that there was no clear strategy offered by KCC in relation to this technology and the siting of the masts.
