- Engaging in an open dialogue with the community of Westgate on Sea to better understand their needs and, in turn, explain how we will address those needs within the resources and powers on the Council
- Working with other groups and organisations to preserve and enhance character, heritage and unique identity of the Town
- Promoting Westgate on Sea as a clean, safe and inviting Town for all
- Helping to create a socially inclusive and caring community which embraces all its residents, irrespective of age, gender, sexual orientation, culture, income, race or religion and seek to develop their understanding and mutual co-operation; working in partnership where possible to achieve more for Westgate on Sea

One of the main tasks of the Council has been to draw up a Neighbourhood Plan, driven by several consultations and surveys to identify the main concerns and aspirations of residents in relation to the town.

ROLE OF THE TOWN COUNCIL

Westgate on Sea Town Council was formed in May 2015, following 80 years under the control of Margate and then Thanet District Council. It comprises 10 Members, and elections are held every four years.

The Council has always viewed its role as supporting, not replacing, the initiatives of local community groups and organisations to strengthen and serve the community. It has been a catalyst for encouraging better co-operation between these groups and has made things easier for them in relation to getting permits and agreements from TDC. Equally, Council has sought to keep any budget increases to the minimum, and needed to maintain best practice towards its employees, and to finance defined programmes of benefit to the town, rather than building up reserves without clear projects. This forward plan is therefore based on projects which imply minimal cost to residents.

The Council employs a Town Clerk and Responsible Financial Officer who manages a dedicated team of five part-time staff, made up of a Project Assistant, a Finance Assistant, and currently three Cleansing Operatives who provide the top-up cleansing services for the Town. The Council offices include a community space for local groups to use, and where local artists can exhibit their work.

A full schedule of meeting dates of Council and the Committees can be viewed on the Westgate on Sea Town Council website together with copies of Agendas and Minutes. Copies of the Council's core governance documents including Standing Orders, Financial Regulations, Terms of Reference for Committees and Publication Scheme, together with key policies can also be viewed on the Council website.
